

Eligibility for New EV Connection:

1. **Application Process:** Consumers must submit a complete application form along with necessary documents through online mode or offline at sub-division office of BESCOM.
2. **Setting up and operation of EV charging station is a de-licensed activity** and any entity is free to establish EV charging infrastructure.
3. Application for EV power supply is applicable for the following cases:
 - a. New Connection (both Single & Multiple connections)
 - b. Tapping Connection for existing building
 - c. Load Enhancement
4. **Safety Standards: Comply with technical, safety, and performance standards outlined by the Ministry of Power and Bureau of Energy Efficiency.**
5. **Compliance: Ensure EV charging setup adheres to guidelines provided by the Central Electricity Authority & Electrical Inspectorate.**

For Applications:

1. Registered through Online:

Photo copy of the documents prescribed as per Clause 4.02(ii) of KERC Regulations shall be submitted along with the original for verification during spot inspection by the field officer.

2. Registered Offline at Sub-division office:

Photo copy of the documents prescribed as per Clause 4.02 (ii) of KERC Regulations shall be submitted along with the original for verification at the sub division office.

New EV connection will be provisioned only after complying with the following:

- a. In case of New connection, temporary connection availed if any shall be surrendered.
- b. In case of existing building , arrears & additional demand charges if any ascertained during spot inspection shall be paid by applicant.
- c. Payment of all applicable Deposits/charges as per the Clause 4.03 of conditions of power supply regulations of KERC.
- d. Power supply Agreement as per Clause 32 of CoS by the applicant.

- e. Registered land deed between Land Owning Agency and the CPO or between lessee and charge point operator in case of sub leased property.
- f. Power of Attorney confirming powers on the person(s) who are competent to execute the MoU / agreement.
- g. Certified copy of Company Registration Certificate. (if applicable)
- h. Copy of PAN Card.
- i. Copy of GST Registration.
- j. Self-Attested copy of Govt. ID Proof of the Authorised Representative.
- k. Petroleum & Explosives Safety Organization (PESO)Approval in case electricity connection required for installation of EV chargers at Petrol Pumps / Gas Stations, shall be sought by CPO.
- l. NOC from fire department (if EV charger is to be installed in the basement of a building).
- m. EV Charger type test certificate from NABL Accredited Lab.
- n. Undertaking on Stamp Paper for using power supply only for public EV charging.

The Application will be completed only after getting the documents (ID and ADDRESS PROOF) duly verified by visiting the concerned SDO.

If the application is rejected due to non-compliance of the above eligibility criteria/ any modification requested with respect to the Load, Tariff & Name will not be considered and subjected to rejection of application then except registration & GST amount all other deposits viz., MSD, AISD and Non-revenue charges viz., SLC and ASLC shall be refunded and all the other charges shall be forfeited.

If applicant is not desirous of availing power supply and has not executed the agreement, the Licensee shall refund the amounts after deducting the 10% of total amount as per clause 4.03 Note of KERC.
